

## **RETURN POLICY**

Returns must be approved by Origin Acoustics prior to any return attempts. Upon approval a Return Authorization number will be provided by the Customer Experience department. A return request can be initiated by calling (844) 674-4461 or emailing Sales@OriginAcoustics.com

Products can be returned for full credit if unopened and in "like new" condition, provided the return is initiated within 30 days of initial receipt of the product. After 30 days products may be returned at the discretion of Origin Acoustics and may incur a 20% restocking fee.

Once a return has been approved and a Return Authorization number has been received, the product must be delivered to Origin Acoustics, with the Return Authorization number, and in its original packaging. If the Return Authorization number is not included the return will be unable to be processed and no credit will be given. If is it not possible to ship product in original packaging, the customer is responsible for insuring the shipment for the full value of the product, or the return may be declined.

## WARRANTIES & RETURN PROCESS



## WARRANTY

Origin Acoustics warrants to the original retail purchaser only that product will be free from defects in materials and workmanship, provided the product was purchased from an Origin Acoustics Authorized Dealer. If the product is determined to be defective, it will be repaired or replaced at Origin Acoustics' discretion. If the product must be replaced yet is no longer manufactured, it will be replaced with a similar product of equal or greater value. In this instance, installing the replacement model may require mounting modifications; Origin Acoustics will not be responsible for any such related costs.

## **REQUIREMENTS & WARRANTY COVERAGE**

Warranty is only valid on product purchased through an Authorized Dealer of Origin Acoustics. Warranty only applies to the individual that made the original purchase, and it cannot be applied to other purchases or transferred. The purchaser must be able to provide proof of purchase(receipt) if requested. Warranty will be void if the identifying number or serial number has been removed, defaced, or altered.

This warranty is in lieu of all other expressed or implied warranties. Some states do not allow limitations on implied warranties, so this may not apply depending on the customer's location. (For more information, see Magnuson-Moss Warranty Act.)
